Dealer's failure to promptly notify Seller of any inconsistency between the products ordered and the product shipped and/or any defects in any of the products received shall constitute an immediate and irrevocable acceptance of the products by the Dealer and will be from there on ineligible to make any claim.

WARRANTY:

Seller warrants the products sold to Dealer in the United States to be free from manufacturer's defects in materials and workmanship under normal consumer usages for a period of fifteen (15) days from the receipt of product by Dealer. Seller may repair or replace such product at their own discretion. If Seller's best course of action is to repair, Seller will use reasonably similar parts to make such repair. Shipping costs to and from Seller for replacement or repairs under Warranty are the sole responsibility of Dealer, and Seller shall only deal directly with Dealer and in NO direct way whatsoever with Customer.
